Shropshire Council Planning Reconsultation - Amendment 18/00939/REM - Proposed Residential Development Land North Of Lower House Farm

RESOLVED to submit the following comments on the amended plans

The Parish Council recognises that the developer has responded to comments submitted by local residents and has amended the plans to address some of these concerns. Having reviewed the amended plans the Parish Council wishes to submit the following comments **Housing Size** - Although the Parish Council requested that at least 50% of the houses should be 3 bedroom properties the Parish Council is satisfied with the new proposed mix of housing sizes on the development.

Road Surface -The applicant does not appear to have addressed this concern raised by the Parish Council on the original application. " As the development is in a conservation area less reliance on tarmac as the final road surface of the estate is to be encouraged. This would ensure that the development is more in keeping with a prominent village position and more in keeping with its countryside setting." Therefore these comments still stand.

Access - The Parish Council is disappointed that road safety cannot be addressed as part of this application. Whilst The Council appreciates that the access to the development was agreed at the outline planning permission stage it is disappointed that the developer is not proposing to do more to address the road safety issues that this development will bring. The majority of the facilities in the village will be on the opposite side of the road to the development meaning that people living in the new development will have to cross a very busy main road in order to access community facilities and road safety is a priority for the parish council

Affordable Housing - This issue has not been addressed in the revised plans and the Parish Council endorses the objection by Shropshire Council affordable housing. There is a need for more rental properties in the village for young families and the Parish Council wish that the affordable home is rented through a housing association and rented out under the terms of the local connection policy.

c) To consider any planning application received after the publishing of the agenda. None

d) To consider planning correspondence concerning the classification of Knockin as a community Hub in the Local Development Review

It was explained that following the Local Development Review consultation in 2017 when Knockin had been classified as open countryside a reassessment of the parish had been carried out by Shropshire Council and the parish had been reclassified as a community hub where limited future development could place. However following the closure of the shop and post office this had once again dropped the parish below the threshold to qualify for hub status. Shropshire Council had since requested that the Parish Council decide whether they wished to be classified as a community hub and allow limited housing development in the next 20 years. A discussion took place and councilors expressed the view that it was important for the parish to grow in order to sustain its remaining facilities and enable struggling facilities to re open. This additional development would also bring in more revenue that may enable the Parish Council to provide play equipment on the Amenity Area and contribute to the building of road safety provision on the main road.

It was RESOLVED to comment that Knockin Parish Council recognises the need for limited housing development in the parish in order to ensure the long term sustainability of the community and its facilities. However road safety remains a major concern of the council and it is vital is that any development should be linked with measures to improve the road safety through the village.

23/18 Parish Matters

a) Kinnerley and Knockin Cricket club – to consider request to fund erection of a plaque to commemorate awarding of QAV. The Clerk reported that the secretary of the club had requested that a decision is deferred on this item as he would like to share the clubs plans with the Parish Council

RESOVLED to invite a representative from KKCC to the September meeting of the Council.

b) Governance review- for update. A discussion took place on the impact that the proposed development behind the war memorial may have on the future sustainability of the parish. Councillors expressed the view that the new development would reduce the need to combine with a neighbouring parish and that no firm decision should be taken on this until after the local plan review

RESOVLED not to progress this matter at this time.

c) Future Fit consultation – to consider Parish Council's response.
 A discussion took place and councilors expressed the importance of keeping the Emergency Care site in Shrewsbury due to the distance to Telford.

RESOVLED that option one where the Emergency Care site is the Royal Shrewsbury Hospital in Shrewsbury and the Planned Care site is the Princess Royal Hospital in Telford is the preferred option of the Parish Council as this option best meets the needs of residents of Knockin in terms of accessibility.

d) Defibrillator/Case – for update. The Clerk reported that checks were now being carried out on the defibrillator but she had no details of who was doing the checks or recording them to request name of person carrying out the checks, register insurance asset register and

RESOVLED that the Clerk ascertains the name of the person carrying out the checks and that the defibrillator is added to the Parish Council's asset register.

e) Request to use Amenity Area for event parking – for consideration.

It was reported that a request had been received from the Rotary Club of Shrewsbury to use the amenity area as overflow parking during a cycle event they were planning to start from the hall.

RESOLVED to approve the request subject to the following conditions Any damage to the ground must be made good by the hirer

In the event of bad weather, in the days running up to the event an inspection will take place of the Amenity Area on the Thursday prior to the event and permission may be withdrawn if the ground conditions are considered to be unsuitable for use as a car park.

The hirer is responsible for safe passage of pedestrians to and from the amenity area

f) Knockin Shop and Post Office - for update meeting to be held 11.7.18 It was reported that discussions are currently taking place to host the post office in the Assembly Rooms either one afternoon a week or once a fortnight and that a meeting was to take place with a representative from the post office to discuss the details.

RESOLVED to note the report
