Cllr Doyle declared a pecuniary interest on item 42/17b) **Planning matters for consideration – 17/05149/FUL** The Shop At Knockin, Knockin, Oswestry, Shropshire, SY10 8HJ as he lives next door to the shop.

38/17 TO CONFIRM THE MINUTES OF THE MEETING HELD ON 12.9.17

RESOLVED to confirm the minutes of the meeting held on 12.9.17 and they were duly signed by the chairman as a true record.

39/17 PUBLIC PARTICIPATION SESSION – a period of 15 minutes will be set aside for the public to speak on any items on the agenda (this may be extended at the discretion of the chairman)

A number of members of the public raised concerns about planning application **17/05149/FUL** The Shop At Knockin, Knockin, Oswestry, Shropshire, SY10 8HJ

Proposal: Internal and external alterations to the existing single shop to create two seperate units (shop/post office and fish and chip shop)

These concerns included;

The parking problems that the increased number of vehicles that the fish and chip shop will attract. It was pointed out there is already a parking problem outside of the shop as customers often park dangerously and block access to neighbouring properties. Concerns were also raised that the extended opening hours of the fish and chip shop would cause parking problems late into the evening.

Environmental objections were also raised including the following

Increase in the amount of litter in the village, impact of noise from the extractor fans on neighbouring properties, impact of smell from the chip shop on neighbouring properties along with the fire risk to neighbouring properties.

Concerns were also raised that the external fire escape and proposed flue as residents were of the opinion that these proposals were not in keeping with the Conservation Area and the staircase would overlook the bedroom window of the neighbouring property which would negatively impact on the privacy of neighbouring residents.

Some members of the public spoke in support of the application and highlighted the need for an application of this type. It was explained that in order for the shop and post office to remain viable it was important that another business is developed in the adjoining section as without this business it may mean that the shop will have to close which would be a big loss to the village. It was also reported that if permission were to be granted for the fish and chip shop this could have a knock on effect of supporting the other businesses in the village.

A resident also stated that if planning permission were to be granted the shop will have to be upgraded to ensure that it complies with all fire regulations.

40/17 REPORTS

Police CSO Charlie Iremonger gave a report on policing issues in the parish. He reported he had carried out speed enforcement in the parish and that there had been a theft of lead from the church roof.

Shropshire Council – Matt Lee Shropshire Councillor for Knockin introduced himself to Councillors as the new Unitary Councillor for Llanymynech. Councillors raised concerns with Cllr Lee over the lack of action in relation to the need for a solid (no overtaking) white line to be painted along The Avenue to prevent overtaking. Cllr Lee offered to look into this issue.

Other reports from councillors attending meetings or training courses on the council's behalf – The Clerk reported that she had attended training on the changes to the Data Protection Act and the impact that this could have on the parish council.

b) Planning matters for consideration

Cllr Doyle – left the room and took part in discussions.

17/05149/FUL The Shop At Knockin, Knockin, Oswestry, Shropshire, SY10 8HJ Proposal: Internal and external alterations to the existing single shop to create two separate units (shop/post office and fish and chip shop)

A discussion took place on the proposals and a suggestion was made on holding a parish ballot to gauge the feeling of the community however the clerk explained that this would not be possible due to the timescale for comments on planning applications set by Shropshire Council

The concerns raised by members of the public were discussed as was the need for the development of an additional business in order to make the existing shop financially viable. Following a vote it was;

RESOLVED to object to the application for the following reasons;

Conservation Area – the proposed external staircase, extraction unit and chimney flue are not in keeping with the Conservation Area.

Loss of Privacy - The proposed staircase will overlook the neighbouring property and the proposals will result in loss of privacy for the neighbouring property.

Environmental Impacts – The noise from the extractor fans along with the smells and fumes from the proposed fish and chip shop will have a negative impact on neighbouring properties. In addition to this the Parish Council is concerned that the proposals will result in an increase of litter in the village.

Highways impact – The location of the Knockin Shop is on a main road with no off street parking. Residents living adjacent to the existing shop already experience problems with customers blocking accesses to houses. The Parish Council considers that if permission is granted for a fish and chip shop this problem will be exacerbated and continue later into the evening as the shop will have later opening hours than at present.

- **d) Shropshire Council Partial Local Plan Review –** for consideration. The Local Plan Review for Knockin Parish was considered and it was

RESOLVED to

- Agree with the methodology has been applied by Shropshire Council to the characterisation of Knockin as outlined in the Local Plan Review and to agree that the proposed threshold of 48 points for the parish was correct.
- Agree that Knockin Parish revert to the category open countryside
- **e) Knockin Place Plan Priorities** for review. The 2017 place plan priorities for the parish were reviewed and it was;

RESOLVED to add the following key priorities to the place plan for Knockin Traffic Calming – There is a need to install entrance gates on verges at the entrance to the village to better mark the beginning and end of the village.

Assembly Rooms – Need to replace existing heating system and make the hall more energy efficient.

a) Quotes for Tree removal – for consideration. – It was reported that confirmation had not been received as to whether the application for a new tree had been approved

RESOLVED to defer this item until the outcome of the grant application for a replacement tree was known.

b) Defibrillator/Case – for update. Cllr Keay reported he has been in discussions with the surgery to have the defibrillator located on the outside of the surgery to make it available for use outside of surgery hours. However this would require fund raising for an external case to house the defibrillator.
