121/15 TO CONFIRM THE MINUTES OF THE MEETING HELD ON 6.5.15

RESOLVED to confirm the minutes of the meeting held on 6.5.15 and they were duly signed as a true record.

A number of members of the public spoke in opposition to planning application14/04884/MAW - Erection of waste transfer station, new portal frame unit and an external area for green waste Knockin Heath Business Park, Knockin Heath, Shropshire. Those speaking felt that the impact on the local residents from excessive noise and dust would be too great.

Concerns were also raised about liquid waste disposal and where that would be disposed of.

The Parish Council is also concerned that the applicant has not addressed the issues they raised in their previous objection relating to the access into the adjacent wood in the revised design and access statement which are copied below

The Parish Council is concerned about recent work undertaken by the applicant on an access to the site from the main road running through woodland West of the site to the Business park. This access which was originally a dirt track and has recently been developed into a stone track. The Council is concerned that land that the access runs over is contaminated land and that the recent improvement works have disturbed land that has been previously contaminated.

The Parish Council is also concerned that as part of the restoration of the access track a number of trees that are subject to tree preservation orders in the woodland have been damaged without permission.

In addition to this the applicant has also installed a new access from the yard into the woodland that is not indicated on the plans
