b) Road Safety Concerns – for update

The Clerk reported that Shropshire Council had suspended the road safety policy for Parish Councils due to a lack of funds. Councillors were frustrated by this decision as despite submitting road safety improvement requests for a number of years as per the policy no improvements had been carried out in the parish. However it was reported that the double white lines along The Avenue were due to be installed this financial year. It was also reported that the new culvert has been installed In The Avenue to prevent the flooding.
