A member of the public highlighted the objection comment from Shropshire Council's Public Protection Team and requested that the Parish Council take notice of this comment when considering any response to the application.

A comment was made the proposals will devalue the neighbouring properties.

Councillors were asked to make their decisions based on planning reasons alone as this there was considerable support for the application amongst residents.

The possible loss of the post office was also raised and it was explained that if the post office was to close it did not necessarily mean that it couldn't be reopened in another location in the village.

Resolved that the Parish Council continue to object to the application as the additional papers submitted by the applicant do not address any of the objections that the Parish Council submitted in November.

The Parish Council request that if the officer in charge of the application is minded to recommend that planning permission be granted, then due to the controversial nature of this application it should be determined by a planning committee.

Resolved to submit the following comments

The Parish Council continues to strongly object to the use of composite material to clad the lodges as well as the use of UPCV for the windows and doors of the lodges.

The Parish Council consider that the permission was granted for holiday lodges and that the appropriate cladding material for a development of this nature should be wood. Point 4.11 of the applicants original design and access statement clearly states that each lodge will be wood clad with slate roofs in order to blend into with the rural setting.

The new proposals for cladding will be out of keeping with the original plans and detract from the rural setting. Therefore the Parish Council request that this application is refused and the applicant be informed that the only material that is acceptable for cladding is wood.
